



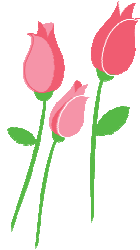

Notes from Commodore Jeff Hardwick

Last newsletter I stated that we will indeed continue to exist as a club and most importantly at our current location & that I would have details in next newsletter. I can now say with complete certainty **“WE ARE HERE TO STAY!!!!”** So don't be afraid to send in your dues money. If you don't know already....I want to let everyone know the Zanesville Yacht Club did indeed purchase 55 shares of stock from the ZYC Investment, Inc for \$220,000.00 and now officially owns 52% of the property. More importantly we now control majority vote of what happens to the land. First order of business was to renew the lease to the Yacht Club. We signed a loan with National City Bank, McConnelsville on March 14th for that amount and now have a mortgage payment of approx. \$1720.00 per month which we feel is very manageable with the increase in dues and continued dock slips, clubhouse rentals and business as usual.

Please try to attend the Installation Banquet, we have some fun things planned. It is always good food, entertainment & great fellowship. Everyone dresses casual except me, I'll don my commodores hat & gold stars for the festivities & make it official with the installation of new members & officers.

ZYC MEMBERS DUES PAYMENT

Let me try to bring everyone up to speed on where we are in terms of current situation with the property. As I mentioned under "Commodores Comments" we are indeed here to stay. But not without some sacrifice. That sacrifice mostly attributing to increase in dues. The dues increase a necessity due to the fact that we, The Zanesville Yacht Club has now signed a loan agreement with the bank to borrow \$220,000 for the purchase of the shares and own 52% of the property. With this sacrifice we hope to receive big rewards. By controlling the majority of shares of the property we will be able to proceed into the future with continued improvements and growth. More improvements to the clubhouse, upgrades to the docks, additional docks, etc, etc, We want to be able to do these improvements, continue to carry on as we have and obviously be able to pay the mortgage we now have. Hence the reason again for the increase in dues to \$300.00 per membership. We know this is a big jump for everyone and have been asked by several if they can make payments. The trustees have come up with the following terms:

PAYMENT TERMS:

Dues \$300.00 + Tax \$21.00 = Total Due \$321.00

\$100.00 due by April 1st

\$221.00 balance due by June 1st

This gives our members 6 months to pay the total amount due and you can send in payments however you wish. For example, \$50.00 a month, \$25 every other week, it doesn't matter to us as long as you have \$100.00 paid by April 1st & balance by June 1st. (If prepaying for 2 years at \$535.00 same terms as above, \$100 by April 1st, balance of \$435 by June 1st))

DOCKAGE MUST BE PAID IN FULL BY APRIL 30TH TO SECURE YOUR SPACE.

SPECIAL NOTE: Charter Members have been given a \$100.00 discount making your dues \$200 + \$14 sales tax. Due date & terms same as above.

NEW MEMBERS THIS YEAR will also receive a promotional discount of \$200.00 initiation fee being waived. **NEW MEMEBRS THIS YEAR WILL PAY \$321.00 to join.** So tell anyone you know who may want to join. **THIS IS THE YEAR TO DO IT.**

NEW MEMBERSHIP APPLCATIONS: We now have put together a new application form which is more extensive & requires a photograph from all new perspective members. This application is now ready & old ones will not be accepted.

THIS APPLICATION ALSO INVOLVES TWO REFERRALS FROM CURRENT ZYC MEMBERS. If that person wanting to join does not know any current members then they must meet with two of our trustees & an interview process will take place before we can vote on their membership.

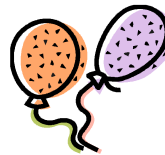
